## JONATHAN E. BUCHAN, JR.

## 2019-20 Recipient of the Ayscue Professionalism Award

The Mecklenburg Bar Foundation (MBF) is pleased to announce that Jonathan E. Buchan, Jr. was awarded the 2019-20 Ayscue Professionalism Award at the October 31 Law & Society Luncheon. The MBF's Ayscue Professionalism Award is presented each year to a present or former member(s) of the Mecklenburg County Bar to recognize exemplary professionalism. Criteria may include outstanding service through or on behalf of the Mecklenburg County Bar or the Mecklenburg Bar Foundation for the benefit of the legal community or the community at large; substantial and significant service to the community, to the Bar, or to the justice system, whether on the basis of lifetime contributions or a specific project; and/or embodiment of the traits to which all attorneys should aspire: high ethical standards, model conduct, unquestioned integrity, and consistent competence.

Jon Buchan grew up in Mullins, South Carolina. After earning an AB degree in political history magna cum laude from Princeton University in 1972, his interest in politics and his lifelong commitment to community led him to return to South Carolina and join others in launching an alternative newspaper, *Osceola*. His work at *Osceola* soon caught the attention of the managing editor of *The Charlotte Observer*, who hired him for the newspaper's Columbia, SC Bureau.

After three years as a reporter, Jon left for Duke Law School, where he earned his law degree in 1978. His life in the law began when he came to work as an associate at Helms, Mulliss & Johnston in Charlotte, the firm that represented *The Charlotte Observer*. In the early 1980s, the *Observer* lured Jon back briefly as its Government Editor, but he ultimately realized he belonged in the practice of law and was welcomed back to his old firm. He practiced as a partner in that firm and its successive iterations (now McGuireWoods LLP) until the end of 2015,

when he joined Essex Richards P.A., where he continues his practice.

Jon has rendered outstanding service to the Mecklenburg County Bar through his efforts as a president of the MCB. His year in office was marked by high creativity and high activity. During his tenure: the Special Committee on Diversity was created; the MCB Speakers' Luncheon program was established; a weekly "Ask a Lawyer" program was launched with TV News 14; a weekly "Talk to My Lawyer" column was launched in The Charlotte Observer; Charlotte hosted the North Carolina Court of Appeals for two days of oral arguments, for the first time since 1989; and the first Judicial Recognition Dinner was held to honor the federal judges of the Western District of North Carolina.

Jon's leadership and involvement in the MCB and MBF did not end there. He went on to chair the Bar Leadership Institute in 2007-08. He cochaired, with George Hanna, the Memorials Committee from 2010-14, and he continues to serve as a committee contributor. He was also a member of the Board of the Mecklenburg Bar Foundation from 2010-13.

Jon's service to the community extends beyond his leadership roles in law-related activities. In 2004-05, he participated in a signature program sponsored by the Community Building Initiative, a nonprofit organization established by government and civic leaders to achieve racial and ethnic inclusion and equity in the Charlotte-Mecklenburg community. The CBI's yearlong Leadership Development Initiative program, in which Jon participated, supports community leaders in the roles they and their organizations play in building a more inclusive and equitable Charlotte-Mecklenburg.
